# Further draft proposals for unitary local government in Suffolk

The Boundary Committee for England is a committee of the Electoral Commission, an independent body set up by the UK Parliament. One of our duties is to advise the Government on local authority bids for unitary status.

On 6 February 2008 the Boundary Committee for England was requested to advise the Secretary of State for Communities and Local Government on the structure of local government in Suffolk.

We were asked to provide advice on whether there was any pattern of unitary local government – one or more councils providing all services currently provided by the county and district councils – that might work for the county area as a whole. Any pattern of authorities that we propose to the Secretary of State should have the capacity to meet the five criteria which she has laid out: being affordable; attracting a broad cross-section of support; delivering neighbourhood empowerment; providing strong strategic leadership; and delivering value-for-money public services.

Since the start of our review, we have spoken at length with and listened to the views of local authorities, businesses, community and voluntary groups, and service delivery partners such as the police

and primary care trusts. We have also listened to the views of the hundreds of residents who responded to our earlier consultation.

We have now published our report *Further draft proposals for unitary local government in Suffolk*. The report contains two patterns of unitary local government which we consider are likely to have the capacity to meet the Secretary of State's five criteria. The report is available on our website.

### Our further draft proposals for Suffolk are:

- a Suffolk unitary authority comprising the existing county of Suffolk
- an Ipswich & Felixstowe unitary authority and a Rural Suffolk unitary authority comprising the rest of the county of Suffolk

These further draft proposals are the same as the two patterns that we published in July 2008, except that we are now proposing that Lowestoft is retained in Suffolk under both patterns.

## What happens next?

When we provide any advice, we want to make sure that it is right for the residents of Suffolk, so we need your views on our further draft proposals. In light of what you tell us, our proposals might alter before we put them to the Secretary of State. Any advice we do provide will be informed by the responses provided by people and organisations across the county.

We welcome views on our further draft proposals. All representations should reach us by **14 May 2009**. You might want to tell us, among other things, which proposal you prefer, how one or both could be made better, or how you feel the neighbourhood empowerment arrangements could work for your village or town. Whatever representations you want to make, we want to know not only what you think, but why you think it.

After 14 May 2009 we will consider all the representations we have received throughout the review. Any advice we give to the Secretary of State must be provided by her deadline of 15 July 2009.

If you have written to us before, we will take into account what you have already said.

However, if you wish to provide any additional information please write to us. We also welcome the views and evidence of those we have not yet heard from.

The Committee places great importance on ensuring openness and transparency in the way we deal with all representations. All representations received will be made available for public inspection at our offices in London.
